

CARFAX Glossary

Accident

This vehicle has had an accident. You will want to know the type, severity, impact location, whether or not airbags were deployed, etc. We recommend that you obtain a thorough inspection by an independent mechanic before purchasing.

CO2 Emissions

CO2 is an abbreviation for carbon dioxide, a gas that is emitted from a vehicle as a result of fuel combustion. The quantity of carbon dioxide released in the exhaust gases is a good measure of the amount of fuel a car is burning. That quantity is measured by the number of grams of CO2 released into the air for every kilometer that is driven.

Inspections

Periodic examination of a vehicle to ensure compliance with road worthiness, emissions and safety requirements.

Ipoteca

"Ipoteca" is a security in flavor of a creditor over a vehicle belonging to the debtor: creditors can protect themselves by taking out an "Ipoteca" on the vehicle. "Ipoteca" creates a lien on the vehicle without preventing the owner from using and disposing/selling the vehicle. The mortgage, once registered, follows the vehicle until the secured claim is extinguished, even if there are subsequent transfers of ownership.

Number of odometer readings

The periodic mileage as reported to CARFAX. A greater number of odometer readings increases the likelihood of correct mileage.

Number of records

A CARFAX record refers to a specific incidence and date in the history of the vehicle. Please note that the history of younger vehicles tends to have fewer entries. CARFAX continuously works on getting more data sources and historical information in order to enrich the report

Ouick Check
